## SEASON PASSES

**ADULT** ..... \$1,400.00  
*Any individual who is over 18 years of age.*

**RESTRICTED ADULT** ..... \$1,080.00  
*Restricts golfing privileges to Monday through Friday only.*

**9 HOLE SEASON PASS** ..... \$885.00  
*Can be used Monday to Friday anytime, and weekends and holidays after 1:00 p.m.*

**NEW ADULT** ..... \$950.00  
*Any individual who is over 18 years of age and did not hold a season pass in the previous two seasons.*

**JUNIOR** ..... \$135.00  
*Any individual who will turn 18 years of age or younger by October 15th of the current season.*

**STUDENT** ..... \$540.00  
*Any individual who will turn 25 years of age or younger by October 15th of the current season, and who is registered full-time in a secondary or post-secondary institution, in the current year, and returning to full time studies in the fall. (Proof of enrolment may be required)*

**YOUNG ADULT** ..... \$675.00  
*Any individual who will turn 25 years of age or younger by October 15th of the current season.*

**SPOUSAL** ..... \$840.00  
*Any person who is married to, or living in a common-law relationship with an adult season pass holder.*

**FAMILY** ..... \$2,250.00  
*Two adults who are legally married, or living together in common-law relationship, with no restriction on the amount of juniors, provided they are dependent children of the adults. Dependent children include any child under the age of 18 and residing with the parents; or those over the age of 18 who are registered in a secondary or post-secondary institution in the current year, and are returning to their studies in the fall.*
