## SEASON PASSES

**ADULT** ..... \$1,500.00  
*Any individual who is over 18 years of age.*

**RESTRICTED ADULT** ..... \$1,150.00  
*Restricts golfing privileges to Monday through Friday only.*

**9 HOLE SEASON PASS** ..... \$920.00  
*Can be used Monday to Friday anytime, and weekends and holidays after 1:00 p.m.*

**NEW ADULT** ..... \$1,050.00  
*Any individual who is over 18 years of age and did not hold a season pass in the previous season.*

**JUNIOR** ..... \$140.00  
*Any individual who will turn 18 years of age or younger by October 15th of the current season.*

**STUDENT** ..... \$560.00  
*Individuals under 25 as of October 15th of the current year, enrolled in secondary or post-secondary education, and returning to full-time studies in the fall may qualify. (Proof of enrollment may be needed.)*

**YOUNG ADULT** ..... \$700.00  
*Any individual who will turn 25 years of age or younger by October 15th of the current season.*

**SPOUSAL** ..... \$875.00  
*Any person who is married to, or living in a common-law relationship with an adult season pass holder.*

**FAMILY** ..... \$2,340.00  
*Two legally married adults or common-law partners with unlimited dependent children. Dependent children include those under 18 living with parents or those over 18 enrolled in secondary or post-secondary education and returning in the fall.*
